IX. STREAM GAGING PROGRAM

Presentation

Mr. Tom Harris, U.S Geological Survey, presented the USGS 2024 Stream Gage Program funding request to fund 73 stream gages, 3 precipitation gages, 1 lake gage, and 75 low-flow gages as part of the surface water program, and 141 wells as part of the groundwater network. For the 2024 Federal Fiscal

year, there is an increase of 2.7% due to an increase in gage costs. The funding will support a statewide gage network as recommended by ODNR and OEPA. The funding request for the 2024 year is \$646,679.

X. FINANCIAL

Fresh Water Series 2023A Pricing Results

Ms. Cameron Mitchell, PFM, provided a post-pricing analysis of the October 17, 2023, Fresh Water Series 2023A pricing. The analysis included the pricing results, market conditions, pre-marketing, pre-pricing, and final yields. Mr. Shields, Loop Capital Markets, as senior manager of the transaction, provided a summary of the transaction.

Approval Resolution Authorizing WPCLF Series 2023C Bonds

Mr. Skruck provided an update on the transaction and Mr. Callender outlined the authorizing resolution.

Presentation of Other Projects Model

Mr. Skruck provided an overview of the modeling programs, capacity, and subsidy grants. Mr. Heigel added the year-to-date grants and loan amounts in the Other Projects Fund providing the funding levels for 2023. Ms. Cameron Mitchell, PFM, explained the Other Projects Fund model criteria and the model results. Mr. Heigel recommends a \$5.8 million grant funding level for 2024.

Allocation of Surplus Releases

Mr. Skruck requested the allocation of resources using the PFM capacity model to recycle 100% of the Community Assistance releases, 85% of Fresh Water releases, and recycle the remaining 15% of Fresh Water releases into the Other Projects Fund.

Monthly Financial Report

Mr. Skruck highlighted the unencumbered balances and reviewed the project cash and loan capacities for the Fresh Water, WPCLF, and DWAF funds.

XI. PRESENTATION OF 2024 BUDGET AND CALENDAR

Mr. Heigel presented the 2024 budget and the 2024 board meeting dates. The 2024 budget included a 6% percent increase to the existing salary budget. The annual compensation analysis identified four staff member's salaries as below market rate. He also noted that United Healthcare medical insurance cost has increased by 8.5%. Mr. Heigel stated in 2024, OWDA will begin the process of updating the loan processing system software.

XII. EXECUTIVE DIRECTOR'S REMARKS

Mr. Heigel thanked Mr. Shields and Loop Capital Markets, and Ms. Cameron Mitchell and PFM for the successful pricing of the Fresh Water Series 2023A bonds. He provided an update on the Brownfield loan payment that remains unpaid for the July 1, 2023 payment due date. The borrower provided information towards a repayment plan and Mr. Heigel will keep the board updated on any further action.

XIII. CHAIRMAN'S REMARKS

Mr. Stewart stated, effective on the December 14, 2023 board meeting, he will be resigning as Chairman, and will remain as a board member. Mr. Stewart stated he has enjoyed working with the OWDA staff and board members as their Chairman.
